We don't have term limits in this state despite the fact that Washington voters passed a term limits initiative. Our Supreme Court held term limits to be an unconstitutional impediment to those seeking public office. Putting aside the soundness of the term limit's law and the judicial repeal of that law, most of us believe that an elected state office should not be a lifetime position. This is especially true for Justices because no part of state government is more isolated than the Supreme Court. The Court would be strengthened by electing a new justice instead of electing an incumbent for a fourth six-year term.

The Supreme Court has become increasingly fragmented in its rulings. Its decisions are too often composed of several separate opinions discussing degrees of concurrence and descent among its members. Descent should never be stifled, but the Court needs to look for areas of agreement and eliminate what looks to others as bickering or nodding to special interests. I would seek to reduce the scope of the Court's decisions to areas of agreement.

Through its rule making powers, the Supreme Court needs to do more to reduce the tremendous cost of litigation. Adopting Federal Court procedures such as electronic service and filing, and placing presumptive constraints on pretrial discovery practice would reduce costs.

The Court currently advises petitioners to expect an eight-month delay before the Court decides whether it will accept a case for review. The Court needs to reallocate its resources to speed the selection of the few cases that it will accept. Otherwise, finality is delayed for the 90% of cases that are not accepted for review.

My trial and appellate experience in courts across our state uniquely qualifies me to understand the concerns of litigants who are controlled from the isolated chambers of the Temple of Justice in Olympia. Unlike my opponents, I have handled cases all across our state, representing governments, businesses and individuals in cases as diverse as consumer protection, construction, civil rights, insurance and the environment. Because my practice is equally divided between representing plaintiffs and defendants, I am in a better position to understand the competing interests presented in cases to the Supreme Court.

Integrity, hard working, inquisitive and able to limit areas of disagreement in resolving disputes.

I'm proud to have played a key role in obtain in the release from prison of dozens of wrongly accused and convicted victims of the infamous "Wenatchee sex ring." As a pro bono lawyer, I pursued the release from long prison sentences of a mentally handicapped husband and wife through a lengthy trial ordered by the Court of Appeals. That trial shattered the sex ring myth and resulted in the release from prison of dozens of mentally and socially handicapped victims of police abuse.

I'm proud that my clients have trusted me with the responsibility of handling so many significant legal problems.
